The following Privacy Policy governs the online information collection practices of Century Automotive Service

Corporation ("we" or "us"). Specifically, it outlines the types of information that we gather about you while you are

using the Centuryservicecorp.com domain (the "Domain"), and the ways in which we use and don't use this

information. This Privacy Policy, including our children's privacy statement, does not apply to any information you

may provide to us or that we may collect offline and/or through other means (for example, at a live event, via

telephone, or through the mail).

Please read this Privacy Policy carefully. By visiting and using the Domain, you agree that your use of our Domain,

and any dispute over privacy, is governed by this Privacy Policy. Because the Web is an evolving medium, we may

need to change our Privacy Policy at some point in the future, in which case we'll post the changes to this Privacy

Policy on this domain and update the Effective Date of the policy to reflect the date of the changes. By continuing to

use the Domain after we post any such changes, you accept the Privacy Policy as modified.

What Information is Collected About Visitors?

The information that we collect about you while you are using the Domain falls into two general categories:

1. Information You Provide to Us.

We may collect and store information, personal or otherwise, that you voluntarily supply either while on the Domain or

in responding via email in connection with a feature provided on the Domain. Some examples of this type of

information include demographic information that you electronically submit when you sign up for access to certain

features on the Domain, information (such as your name or email address) that you electronically submit when you

register for news, sweepstakes or contests on the Domain, information that you post as part of support questions or

comments, and information contained in search requests or questions that you submit to the Domain. If you decline to

supply or provide us with certain information while using the Domain, you may not be able to use or participate in

some or all of the features offered through the Domain.

2. Information that is Automatically Collected.

We also collect and store information that is generated automatically as you navigate through the Domain. For example, to enhance your experience on the Domain, we use a standard feature found in browser software called a "cookie." Cookies are small files that your web browser places on your hard drive for record-keeping purposes. By showing how and when visitors use the Domain, cookies help us track user trends and patterns. They also prevent you from having to re-enter your preferences on certain areas of the Domain where you have entered preference information before. Centuryservicecorp.com also uses web beacons (single-pixel graphic files also known as "transparent GIFs") to access cookies and to count users who visit the Domain or open our HTML-formatted email messages. Another example of information that we automatically collect as you navigate the Domain is information about your computer's connection to the Internet. This information allows us, among other things, to improve the delivery of our web pages to you and to measure traffic on the Domain.

In addition, certain third party companies (service partners) may collect information from you via cookies, web beacons, clear .gifs or similar technologies. These third parties may use the information they collect to help measure and research the effectiveness of their services, or for other uses. The use and collection of your information by these third parties is governed by the relevant third party's privacy policy and is not covered by our privacy policy. Indeed, the privacy policy of these third parties may be different from our privacy policy. If you want more information about the privacy policies of these third party advertisers and ad servers or want more information on how to opt-out of the cookies or web beacons that some companies may use, we suggest you visit the domain for each of the partner companies.

How is this Information Used?

We use the information we collect from you while you are using the Domain in a variety of ways, including using the information to customize features and advertising that appear on the Domain. We also may provide your information to third parties, such as service providers, contractors, and advertisers, for a variety of purposes.

We reserve the right to use and to disclose to third parties all of the information that we collect online about you and other visitors in any way and for any purpose, with one important exception. We will not use the information that we collect online from you while you are using the Domain, nor will we authorize third parties to use such information, to mail or email promotional offers directly to you unless you have specifically informed us that you would like to receive promotional offers from us and/or from third parties. If you choose to receive these promotional offers, then your information may be used for direct mail or email marketing.



Please also keep in mind that whenever you voluntarily make your personal information available for viewing by third parties online – for example on message boards, through email or web logs, or in chat areas – that information can be seen, collected and used by others besides us. We cannot be responsible for any unauthorized third party use of such information.

The Domain may at times include links to other domains and provide access to products and services offered by third parties, whose privacy policies we do not control. When you access another domain or purchase third party products or services through the Domain, use of any information you provide is governed by the privacy policy of the operator of the Domain you are visiting or the provider of such products or services.

We also make some content, products and services available through our Domain through cooperative relationships with third party providers, where the brands of our provider partner appear on the Domain in connection with such content, products and/or services. We may share with our provider partner any information you provide, or that is collected, in the course of visiting any pages that are made available in cooperation with our provider partner. In some cases, the provider partner may collect information from you directly; in which cases the privacy policy of the provider partner may apply to the provider partner's use of your information. The privacy policy of our provider partners may differ from ours. If you have any questions regarding the privacy policy of one of our provider partners, you should contact the provider partner directly for more information. In addition, certain affiliated Century Automotive Service Corporation and/or MAPFRE ASISTENCIA divisions provide online services that are separate from our Domain and may be subject to privacy policies that are different from ours. If you have any question about the privacy policy that applies to the online service you are using, you should click on the relevant link on the page of the service that you are using.

Be aware that we may occasionally release information about visitors when release is appropriate to comply with law, to protect the rights, property or safety of users of the Domain, the public, or Centuryservicecorp.com.

Please also note that as our business grows, we may buy or sell various assets. In the unlikely event that we sell some or all of our assets, or our Domain is acquired by another company, information about our visitors may be among the transferred assets.

Children's Privacy Statement



This children's privacy statement explains Centuryservicecorp.com's practices with respect to the online collection and use of personal information from children under the age of thirteen, and provides important information regarding their rights under federal law with respect to such information.

• This Domain is not directed to children under the age of thirteen and we do NOT knowingly collect personally identifiable information from children under the age of thirteen as part of the Domain. thirteen as part of the Domain, we do NOT condition the participation of a child under thirteen in the
Domain's online activities on providing personally identifiable information.
